Deadline: Saturday, March 20, 2010  
9:30 a.m. to 11 a.m.

**Eligibility**

Entries will be accepted from residents of Orange County (proof required), ages 18 or older. All entries must be original and have been executed within the past two years.

**Honorarium**

First place: \$500, second place \$250, third place \$125, and City Hall Choice \$50.

**Competition Description**

"Art That's Small At City Hall" is an open exhibition coordinated by the City of Laguna Beach Arts Commission. All works deemed acceptable will be exhibited at Laguna Beach City Hall, located at 505 Forest Avenue, from **March 20** through **April 29, 2010**.

**Entry Requirements**

A fee of \$15 will be charged with only **one entry** allowed per artist. Payments by check must be made payable to the City of Laguna Beach or cash payment is accepted. Artwork must be no larger than 12" along any edge, including the frame, and 3" in depth. Artwork may include oil, acrylic, watercolor, photography, drawing, mixed media and relief. Artwork must be dry, suitably framed, secure and wired for wall hanging. **No sawtooth hangers or sandwich glass will be accepted.** The City of Laguna Beach Arts Commission reserves the right to reject submissions it deems inappropriate.

**Timeline**

**Saturday, March 20, 2010**

9:30 a.m. – 11:00 a.m.

Artwork, with applications attached, and entry fee must be delivered to the main entrance of City Hall, 505 Forest Avenue. Any submissions submitted after the deadline will not be accepted.

**Thursday, April 1, 2010**

5:00 p.m. – 6:00 p.m.

Reception and awards ceremony held at Laguna Beach City Hall prior to First Thursday's Art Walk.

**Friday, April 30, 2010**

9:30 a.m. – 11 a.m.

Exhibition closes. All artwork must be collected at Laguna Beach City Hall. Participants will be charged \$10 per day for work left past Noon on Friday, April 30, 2010.
