Eligibility:

Open to all Orange County artists 18 years of age or older. Work must be original and executed within the past two years. Work must not have been previously exhibited at City Hall. Entry in this exhibit establishes an agreement on the part of the artist to all conditions listed in the prospectus.

Media: Two dimensional art works measuring no more than 36" x 36" framed.

Entry Fee: A non-refundable entry fee of \$20 for up to three entries must accompany submissions. Checks should be made payable to: City of Laguna Beach.

Juror: Martin Betz

Martin Betz was recently appointed Exhibitions Director at the Festival of Arts, Laguna Beach. With over twenty years of experience, Martin has been the Cultural Arts Division Head for the City of Temecula; President and CEO at the Hui No'eau Visual Art Center, Makawao, Maui; Senior Curator and Head of Exhibitions at the Long Beach Museum of Art and was Gallery Director at Claremont Graduate University. Martin has a Master of Fine Arts from the Claremont Graduate University.

Entry Procedures: Submit one (1) disc for preliminary judging. Up to three (3) pieces may be entered. All CD digital images must be in Jpeg format only. Images should be saved at the highest Jpeg setting, and sized at 72 dpi with the longest side of the image set at 12". Each Jpeg should be titled with the artist's name and image number. Compact disc and case must be clearly labeled with the artist's full name.

Condition of Entries: All work must be completely dry, framed, wired and ready for hanging, or otherwise suitably prepared for exhibition. No sawtooth hangers will be accepted.
